MINUTES OF THE TECHNICAL BID OPENING "Renting Out 48 Government Rest Houses for the Period of Ten Years"

The subject meeting was held on 15.09.2020 (Tuesday) at 03:00 PM, in Conference Room of the Department of Tourism, 13-A Khyber Road Peshawar Cantt.

Technical bids were opened by the subcommittee notified vide notification # SO(T)5-18/2019/8609-14 for the subject bidding before the representatives of the firms.

PROCEEDINGS:

After recitation from the Holy Quran, the Chairman Committee asked the firms to introduce themselves along with relevant experience of your firm.

Procurement Specialist KITE, informed that in response to the advertisement in Newspapers, KPPRA and KPCTA website, total 70 (Seventy) firms purchased the bid solicitation documents. 33 (Thirty Three) firms attended the pre bid meeting held on 25-08-2020, However, the following 18 (Eighteen) firms submitted their technical bids details are mentioned below.

Sealed envelopes (Only technical bids) of each firm were publically opened by announcing the name of the firm. All the members of the subcommittee signed on the sealed envelopes and technical bids.

It was also announced that bids shall only be evaluated against the eligibility / evaluation criteria and other terms & conditions mentioned in the Bid Solicitation Documents. Financial bids of only technically qualified bidders will be opened.

DECISION:

After opening the bids, bidders were informed by the committee that evaluation process will be completed within the stipulated period and evaluation report shall be hoisted on the KPPRA and KPCTA website required under KPPRA Rules 2014. If any of the firms has any query, they may approach in writing the subcommittee or the Director General, Khyber Pakhtunkhwa Culture and Tourism Authority, otherwise financial bids of the qualified bidder shall be opened.
