MINUTES OF THE TECHNICAL BID OPENING ON LEASING OF HAMALA HOUSE, HELD ON 11-08-2021 AT 03:00 PM

In pursuance to the advertisement placed in leading daily newspaper dated 27th July, 2021 the technical bids of the subject leasing were opened on 11-08-2021 at 03:00pm in the conference room of the department of Tourism, 13-A Khyber Road, Peshawar Cantt under the Chairmanship of Director General, Khyber Pakhtunkhwa Culture and Tourism Authority (KPCTA). The following Officials/Officers attended the meeting:

PROCEEDINGS:

After recitation of the Holy Quran, The Chairman subcommittee welcomed the participants of the meeting and requested the representative of the firms to introduce themselves. (Copy of attendance sheet enclosed).

Sealed envelopes (Only technical bids) of each firm were publically opened by announcing the name of the firms. All the Officials/Officers signed on the sealed envelopes and technical proposals. It was also announced that bids shall only be evaluated against the eligibility/evaluation criteria and other terms & conditions mentioned in the Bid Solicitation Documents. Financial bids of only technically qualified bidders will be opened.

After opening of bids, bidders were informed by the committee that evaluation process will be completed within the stipulated period and evaluation report shall be hoisted on the KPPRA and KPCTA website required under KPPRA Rules 2014.

M/s Happy Mountain (Pvt) Ltd. submitted loose documents in their bids therefore this authority won't be responsible for misplacement of any documents. If any of the firms has any query, they may approach in writing within three working days, bids of the qualified bidder shall be opened only.
