This Addendum forms part of the "Bidding Document NCB-10" and modifies/clarifies the original "Bidding Documents" for "Procurement of Waste Management Equipment" of PMU-ERKP Project Khyber Pakhtunkhwa having its principal office located at House # 46 D/3 Old Jamrud Road University Town Peshawar.

The following clarifications/additions/rectifications are applicable to the Bidding Documents

Part Two. Section VII, Schedule of Requirement Lot-II. Sr. No: 9 of the bidding documents (Truck Chassis). (Page. 12)

Deleted: Width: 1950 ~ 2100 mm.

Substituted: Width: 1950 ~ 2300 mm.

Part Two. Section VII, Schedule of Requirement Lot-III. Sr. No: 7 of the bidding documents (Dumper Truck 4x4) Transmission: (Pager-14)

Deleted: 5 Forward & 1 Reverse.

Substituted: 5 Forward (minimum) & 1 Reverse.

Part Two - Section VII. Eligibility for the Provision of Goods, Works and Services in Bank-Financed Procurement, Special Conditions of Contract, Warranty (GCC Clause 15) Page-9

Added:

- i. Warranty Period for Excavator is 2 Years or 3500 hrs whichever comes later.
- ii. Warranty period for Garbage container is Two Year.
- iii. Warranty Period for Dumper Truck and Garbage compactor 2 years or 200,000 Km whichever comes later,

Part Two - Section VII. Eligibility for the Provision of Goods, Works and Services in Bank Financed Procurement ITB 13.3 (d)

Preparation and Submission of Bids, Qualification requirements. Page-5

Deleted: With a minimum of Ten (10) years of experience in supplies of similar nature machinery/equipment. Should have a documented track of completing at least Fifteen (15) similar assignments, during last five (5) years.

Substituted: For Lot no1, Lot no 2 and Lot no 3 With a minimum of Ten (10) years of experience in supplies of similar nature machinery/equipment. Should have a documented track of completing at least Ten (10) similar assignments, during last five (5) years

Added: In case of Lot no 4 a minimum of Five (05) years of experience in supplies of similar nature machinery/equipment. Should have a documented track of completing at least Ten (10) similar assignments, during last Five (5) years.

Added: In case of Garbage compactors both chasses and super structure should be ISO certified.

Added: The eligibility criteria of 10 years' experience is applicable on Lot-1, Wheel Excavators, Lot -2 Garbage Compactor 4M3including Chassis 4x4 & Lot-3 Dumper Truck 4x4 along with the Super Structure.

The specification items and terms conditions of the Bidding Documents remains the same.
